TO: Keeley Gonyea, Municipal Clerk of the Town of Hermon: You are hereby required in the name of the State of Maine to notify the voters of this municipality of the election described in this warrant and notice of election.

TO THE VOTERS OF THE TOWN OF HERMON: You are hereby notified that a United Technologies Center (Region 4 Southern Penobscot County Vocational Region) referendum election will be held at the Patricia A. Duran School, 235 Billings Road in the Town of Hermon on Tuesday, November 5, 2024 for the purpose of determining the following question:

Question 1: Shall the Cooperative Board of United Technologies Center (Region 4 Southern Penobscot County Vocational Region) be authorized to issue bonds or notes for minor capital purposes in an amount not to exceed \$1,874,300 to acquire advanced industry standard equipment to modernize 18 of the 23 programs at UTC and train students for careers in high-demand fields?

Debt service on the bonds or notes shall be paid by the State of Maine with no impact on local educational taxes.

The polls must be opened at 7:00 A.M. and closed at 8:00 P.M.

The Registrar of Voters will hold office hours while the polls are open to correct any error in or change a name or address on the voting list, to accept the registration of any person eligible to vote, and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.
