8. WORKSHOPS

A. Dale St. Louis – Potential Partial Zone Change to Residential B. Tax Map and Lot 054-008-000

The board discussed the potential partial zone change with Code Officer Jessefa Murphy and Dale St. Louis. The board saw no major issues that stood out to them regarding the potential partial zone change.

B. Commercial Kennel Ordinance Amendment

Code Officer Jessefa Murphy let the board know that during the monthly Ordinance Committee meetings it had been brought up that a commercial kennel was looking into moving into town. The current Commercial Kennel Ordinance requires five acres of land. Where the potential commercial kennel would like to go has no residential area around it and it is all industrial. In discussion with the committee, it had been agreed on that it would make sense to reduce that acreage requirement to one and half acres. Jessefa Murphy wanted to bring it in front of the board to let them know it could be brought before them at one the next meetings as an Ordinance Amendment.

9. CEO Items

A. Code Report – September

-For September we issued a total of 15 building permits, which equates to 2 Residential Homes, 1 manufactured home, and 12 accessory permits (2 garages, 2 sheds, 1 addition, 4 decks, 1 pool, 1 roof mounted solar array for personal use, and 1 accessory) for a total of \$1,900,000 in new construction. We issued 12 plumbing permits made up of 5 internal and 7 Sub Surface permits.

-We finalized inspections on 3 new homes for the month of September. We have 141 total open building permits which equates to 81 Accessory, 43 New Home construction (Single Family, Manufactured, and 2-3 units, and multifamily 4+ units), and 17 commercial permits (includes commercial and commercial accessory) that will most likely be completed within the next 2 to 18 months.

-The 7 years average for new single-family homes built in Hermon is 37.0 per year. 1 subdivision was submitted to the planning board for approval.
